Old business:

- Tom Vicchiariello reported that he was in possession of a **signed agreement** between the Red Cross and PJSD for an evacuation procedure. - NY Alert is available for PJ use but not many have signed up. A renewed effort should be initiated to get more residents on board. Reverse 911 was also briefly discussed.
- There was a discussion about the lights on the Matamoras PJ Bridge. There is no history of the City replacing the lights and it has been stated that Penn DOT is responsible. We will research who is responsible and Mayor Elect Decker suggested that we look into adding LED fixtures to the bridge. Stan Siegel suggested to just replace the bulbs.
