William Onofry 130 West Main Street SBL: 17-2-3 Conditional use permit for a two family in an R-1 zone

All mailings are on file.

Mr. Onofry stated the applicant is taking the current use of a single family and requesting a two family. The variances necessary have been obtained from the zoning board. There is sufficient parking and have been placed in a position to be able to come before the planning board for a special use permit. Property does extend slightly beyond the property on the right side.

Mr. Vicchiariello asked if the old driveway along West Main street can be turned into green space and relinquish curb cuts. Mr. Onofry is agreeable with conditions to be set on application.

Mr. Vicchiariello questioned the yard area as is. Mr. Onofry replied the answer is preexisting blacktop. He agrees to the greenspace to the left and will provide six parking spots in total.

Mr. Vicchiariello questioned drainage issues. Mr. Onofry cannot determine drainage issues since property was acquired in January. Mr. Vicchiariello noted the next door neighbor at 132 West Main street has its basement getting flooded due to the slope from the property. Also, when the yard fills up with water it runs off the neighboring yard. Mr. Onofry voiced concern with the cost of ripping up the black top. Mr. Vicchiariello suggested regrading with a top on it. Tenants from the house have complained. The project cannot be approved when we know water is going to the neighbors and is constantly flooding the basement. Mr. Onofry asked for the expectation of the board. Mr. Vicchiariello noted to mitigate the issue with an inch or two layer of blacktop pitched to Union Street.
