She questioned if the IDA wants to issue a reminder in May of 2015 to them reminding them of their obligation especially in light of the many management changes at the Hospital the Federal Depository Trust will only provide notice at 45-60 days before the payment is due. She noted that the last time Bon Secours had to make a bond payment was 2008.

A motion was made by Frank Bell and seconded by James Hinkley to go into executive session for the purpose of attorney-client privileged discussion regarding the Future Homes matter and FOIL Request with invitation to the City Clerk Treasurer.
