Mr. McCarthy called the meeting to order for the purpose of review of the documents for the turnover of Future Homes to Excel Homes.

Mr. Coffill indicated that Future Homes has been having issues with the bond and the associated letter of credit that future homes is seeking. They may be paying off the remaining Bond of \$380,000 to avoid this conflict. Future homes would be ameniable to the lease continuing throughout the original bond period such that the PILOT agreement continue. Excel homes has stated that the pilot continuing is integral to their plans. Modified lease agreement copies of all revised have been circulated to the members.

Mr. Coffill indicated that he will follow-up with the parties involved. Mrs. Waizenegger also indicated that she will need a confirmation of the payment of the bond. Mr. Fox and Mr. Coffill conferred to have Mr. John Longabucco sign the prepared documents for execution .

It was noted that by Mr. McCarthy that no agreement can be finalized without the approval of the City.
