Mayor's Correspondence-

Invited citizens to the Annual Rick Drew Memorial tree lighting Friday November 27th at 6:00pm the West End Park. Mayor Decker spoke about how residents are awakened by the 2016 proposed budget and the financial situation the City is currently in. He went on to clarify how Local Government works here in Port Jervis, how we have what is called a Weak Form of government, which means that the mayor has no voting power, the council makes all decisions.

Mr. Decker also ensured citizens that the State Controller's Office has conducted a field and desk audit for the City along with a full audit from a private firm.

Warns residents of the infrastructure issues the City faces, such as the Sewer Project, Tri-State Bridge and the underpass, all which are going to need major repairs which tax payers pay for.

Mayor Decker explains when he received the rough draft of the City's 2016 budget the increase for residents would be 24.4% and while working with the City Clerk Treasurer, they got the figure down to 14.4%.

After the first budget workshop Mr. Decker stated he was approached regarding the accuracy of the figures outlined within the proposed budget. After this concern was brought to the City Clerk Treasurers attention, a clerical error was discovered. The correct increase to residents outlined in the Mayors 2016 proposed budget is 17.4%.

Mayor Decker could not swallow 17.4% increase to residents; therefore he worked with Frank Bell and the City Clerk Treasurer to find cuts that wouldn't disturb services catastrophically. Several cuts were made and together they were able to get the percentage down to 8.93%.

He urges the council to make additional cuts where they can, but to not reduce anymore services.

City Clerk Treasurer's Report-

Apologized for the input error that was made during the preparations of the proposed budget. The error did not impact the level of expenditures or revenues that were in the budget. To stay within the State tax cap, the City would have to increase revenues or reduce expenditures in the amount of \$773,000.00.

Mrs. Waizenegger admits that in prior years the council has approved the spending of reserved funds to balance the budget which has depleted the fund reserve to around \$200,000.00.

She explained that the Orange County Sales Tax sharing agreement is based on population of each city within the county. The City's census was down, therefore, our percentage of sales tax revenue goes down reducing revenue by \$300,000.00 Announced a scheduling conflict with the finance meeting and the Fire Department elections being held on the same evening, December 17th, due to not having a Deputy Clerk, Mrs. Waizenegger will have to reschedule the finance meeting.


