A. The Front, 61 Front St. SBL: 13-4-2; mistake from assessor's office; original paperwork was missing new (26') parcel; 3 new additional neighbors mailed, application was accepted and approved.

All refuse including tires will be removed once a week; M.Perry speaking on behalf of the neighbors in opposition to the project. Submitted documents and photos; F.Stefan direct nextdoor neighbor spoke in favor of the project; C.Arghir spoke in opposition of the project; P.Gould again spoke in favor and commented the space is within the existing R/C zone.**
